Armis Vulnerability Intelligence Database Terms of Use

By exercising the Licensed Rights (defined below) granted to you under this Public License including its License Elements of Attribution, Noncommercial, and Share-Alike (as defined below), You accept and agree to be bound by the terms and conditions of this License ("Public License"). You are granted the Licensed Rights in consideration of Your acceptance of these terms and conditions, and the Licensor grants You such rights in consideration of benefits the Licensor receives from making the Licensed Material available under these terms and conditions.

Section 1 – Definitions.

a. License grant.
